

## PUBLIC NOTICE OF FINAL ENVIRONMENTAL ASSESSMENT AND FINDING OF NO SIGNIFICANT IMPACT – TAXIWAY T EXTENSION AT BRADLEY INTERNATIONAL AIRPORT

## **Connecticut Airport Authority**

The Connecticut Airport Authority (CAA) announces the availability of the Final Environmental Assessment (Final EA) for the Taxiway T Extension (the Proposed Action) at Bradley International Airport (BDL). The Final EA has been prepared in accordance with the following: Federal National Environmental Policy Act (NEPA) of 1969, as amended; Federal Aviation Administration (FAA) Order 1050.1F; FAA Order 5050.4B; Executive Order 11990 – Protection of Wetlands; and Sections 401 and 404 of Clean Water Act (including Section 33 U.S.C. 1344).

The purpose of the Proposed Action is to continue Taxiway T on the east side of Runway 15-33 to the Runway 15 end as documented and recommended in the 2019 Airport Master Plan. The need for the Proposed Action is to 1) alleviate safety concerns associated with Hotspots 1 and 2 and active runway crossings, and 2) increase efficiency of airfield operations by providing direct access to and from runway ends and airfield development.

The Final EA identifies, documents, and evaluates the environmental, social, and economic consequences of the Proposed Action in accordance with its authorized project purpose and need. After careful consideration of the information contained in the Final EA, the FAA has determined that significant environmental effects will not result from the Proposed Action. Therefore, the FAA has issued a Finding of No Significant Impact (FONSI).
